TERMS OF REFERENCE :

A member of the State level Co-Ordination Committee so nominated shall hold services for a term of 3 (three) years from the date of his appointment. Terms and conditions of services of members of the Committee shall be governed by section 14 and other relevant provisions of the Act.

Functions of the State Level Co-Ordination Committee shall be to serve as the State focal point on disability matter and facilitate the continous evolution of a comprehensive policy towards solving the problems faced by persons with disabilities and in particular :-

- 1) To review and co-ordinate the activities of all the Departments and other Governmental and non-Governmental organization which deal with the matters relating to persons with disabilities.
- 2) To develop a State Policy to address issues faced by persons with disabilities.
- 3) To advise the State Government on the formulation of policies, programmes, legislation and projects with respect to disabilities.
- 4) To review in consultation with the donor agencies, their funding policies from the perspective of their impact on persons with disabilities.
- 5) To take such other steps to ensure barrier free environment in public places, work places, schools and other institutions.
- 6) To monitor and evalute the impact of policies and programmes designed for achieving equality and full participation of persons with disabilities.
- 7) To perform such other functions as may be prescribed by the State Government.
