- (2) Any form of research to be conducted on disability which involves invasive methods of data collection shall need the approval of the Committee. The researcher/research organization will have to satisfy the Committee with its queries.
- (3) The Committee may cause itself or any other entity to undertake research on issues/matters related to disability especially in rehabilitation including development of aids and appliances through innovation.
