NOTIFICATION


The Governor of Mizoram is pleased to notify the procurement of hearing aid for medical reimbursement in consideration with the welfare of Persons with Disabilities (PWDs) on the following conditions:

1. Reimbursement may be extended for procurement of Hearing Aid only for employees of the Government of Mizoram who entered Government service under the disabled quota and having authentic Hearing impaired Certification from the authorities' appointed by the Government of Mizoram.
2. The maximum rate reimburseable is fixed at Rs 10,000 /- for body worn/ pocket/ behind the ear type/ in the canal type, as per the requirement of the patient for one-sided Hearing Aid and upto Rs 20,000/- for patients requiring bilateral Hearing Aid on the basis of his/ her hearing loss and its attendant disability/ speech training requirement, rehabilitation- specially in child and job requirement in adult [as per CS (MA)Rules]. Reimbursement of Hearing Aid may be permitted on the recommendation of the ENT specialist of the Government/ recognized hospitals on the basis of the audiogram given by him/ her, identifying the degree and nature of deafness Or on the basis of a condemnation certificate from a technical expert (service Engineer of the authorized Hearing Aid Centre/ Dealer).
3. Reimbursement is permissible only if he/ she had not been reimbursed a Hearing Aid in the preceding five years.
