NOTIFICATION

No. A. 12034/1/2000-P&AR (GSW), the 23rd March 2000. In the interest of public service and in exercise of the powers conferred under Proviso to Article 309 of the Constitution, the Governor of Mizoram is pleased to make the following scheme namely :—

1. Preamble : This scheme is formulated for giving scope for regularisation of Muster Roll Employees to regular posts under the Government of Mizoram.
2. Short title and Commencement : This scheme shall be called "Regularisation of Muster Roll Employees Mizoram Scheme, 2000".
It shall come into force from the date of publication in the Gazette.
3. Application : This scheme shall apply to all Muster Roll Employees in Group 'C' and Group 'D' categories under a Departments under Government of Mizoram who were duly employed by means of engagement-orders/cards issued by the competent authority.
4. Regularisation : (i) Any person who has been continuously engaged in in Muster Roll Employees capacity in Group 'C' or 'D' categories in the Department for at least 7 (seven) years shall be eligible for regularisation in a corresponding regular post prescribed for direct recruitment in the concerned Recruitment Rules, subject to availability of vacancy.

Provided that such Muster Roll employees should possess the required educational and other qualifications prescribed in the relevant Recruitment Rules.

Provided further that such regularisation shall be made subject to satisfactory performance reports for the last 5 years, prepared by the Controlling Officers,

(ii) such regularisation shall be considered in order of the length of service in the Muster Roll Employees capacity.

(iii) 25% of vacant posts under direct recruitment may be reserved for Muster Roll employees or as the Government may determine from time to time.

5. Condonation of Age : Age of a Muster Roll Employees may, while considered for appointment to a regular post, be condoned by the Government unless such an employee was already overaged at the time of initial engagement, for such regular appointment.
6. Regularisation not as of right : Notwithstanding anything contained in this scheme, such regularisation shall not be claimed by any Muster Roll Employee as a matter as of right.

In the interest of public service and in exercise of the powers conferred by proviso to Article 309 of the Constitution, the Governor of Mizoram hereby makes the following amendment to the Regularisation of Muster Roll Employees Mizoram Scheme, 2000 (hereinafter referred to as the Principal Scheme) notified Vide No. A. 12034/1/2000-P&AR dt. 23.03.2000 and published in the Mizoram Gazette, Extra Ordinary Issue No. 149 dt. 10.05.2008.

Short title and commencement

1. (1) This Scheme may be called "Regularisation of Muster Roll Employees Mizoram (Amendment) Scheme, 2008.
- (2) It shall come into force from the date of publication in the Official Gazette.

Amendment of Para 4.

2. In the Principal Scheme, for para 4, the following shall be substituted, namely :-
 "Any person who has been engaged on Muster Roll basis in Group 'C' or 'D' category in the Department for at least 7(seven) years, shall be eligible for regularization in corresponding regular post prescribed for direct recruitment in the concerned Recruitment Rules subject to availability of vacant post"

No.A.12034/1/2009-P&AR(GSW), the 12th March, 2018. In the interest of public service and in exercise of the powers conferred under Proviso to Article 309 of the Constitution, the Governor of Mizoram is pleased to make the following scheme, namely -

1. **Preamble** : This scheme is formulated for giving scope for regularization of Muster Roll Employees to regular posts under the Government of Mizoram.
2. **Short title and commencement** : This scheme shall be called "Government of Mizoram Regularization of Muster Roll Employees Scheme, 2018"
It shall come into force from the date of publication in the Mizoram Gazette.
3. **Application** :
 - 1) This scheme shall apply to all Muster Roll employees in Group 'C' and 'D' categories under a Department of the Government of Mizoram who were duly employed by means of Engagement Cards issued by the competent authority with prior approval of Department of Personnel & Administrative Reforms and Finance Department under the Revenue Expenditure heads of account of the State and upon the recommendation of the Departmental Promotion Committee duly constituted by the Government in respect of Muster Roll employees engaged on or after 19.02.2014 (i.e. on or after issue of DP&AR OM No.A.32012 /1 /2013-P&AR(GSW)/Pt, dated 19.02.2014).
 - 2) This scheme shall not be applicable to Muster Roll employees engaged on co-terminus basis under the State Government, Centrally Sponsored Scheme and any other scheme borne employees.
4. **Regularization** : Any person who has been continuously engaged on Muster Roll capacity for not less than 7 (seven) years as at Para 3 above shall be eligible for regularization to the corresponding post on the condition that -
 - i) such Muster Roll employee should possess the educational and other qualifications prescribed by the relevant Recruitment Rules for the corresponding post;
 - ii) the performance reports of such Muster Roll employee prepared by the Controlling Officer(s) for the preceding 5 (five) years shall not be below the prescribed benchmark;

- iii) such regularization shall be made in order of the length of service on Muster Roll capacity as given in the Order of fixation of final inter-se-seniority issued by competent authority subject to clause (ii) above;
- iv) such regularization shall be made against 35% of the direct recruitment quota in the corresponding post
5. Pension & other retirement benefits : The Pension and other retirement benefits of any Muster Roll employee regularized under this scheme shall be governed by the relevant Pension Rules/Scheme in force at the time of such regularization.
6. Condonation of age : Upper age limit of a Muster Roll employee may, while being considered for regularization under this scheme, be condoned by the Government for such regularization unless such an employee was already over-aged at the time of initial engagement.
7. Counting of past service : The past service rendered by an employee on Muster Roll capacity shall not count for any purpose in the event of regularization under this scheme.
8. Appointment as of right : Notwithstanding anything contained in this scheme, such regularization cannot be claimed by any Muster Roll employee as a matter of right.
9. Repeal & Savings : The Regularization of Muster Roll Employees Mizoram Scheme, 2000' and its subsequent amendments framed by the Government of Mizoram and notified vide No. A. 12034/1 /2000-P&AR (GSW) dated 23.03.2000, No.A. 12034/1 /2000-P&AR(GSW) dated 04.08.2008, No. A. 12034/1 /2009- P&AR (GSW) dated 01.09.2009, No.A. 12034/4/2010-P&AR(GSW) dated 19.01.2011 and No.A.12034/ 1 /2009-P&AR(GSW) dated 09.10.2014 and issued in the Mizoram Gazette Extraordinary issue No. 149 dated 10.05.2000, No.294 dated 12.08.2008, No.24 dated 20.01.2011 and No.505 dated 20.10.2014 stand hereby repealed with effect from the date of commencement of this scheme.

Provided that any order made or anything done or any action taken under the scheme so repealed or under any general order ancillary thereto, shall be deemed to have been made, done of taken under the corresponding provisions of this scheme.
