2. The provisions contained in para 2, 3 and 4 of this Department's O.M. of even No. Dt.26.07.2013 shall continue to be applicable while regulating Dearness Allowance under this order.



Consequent upon the sanction of Dearness Allowances by Government of Mizoram vide Finance Department's Office Memorandum No. G.14015/1/2016-FIN(PRU) Dt. 18.10.2017, all Drawing and Disbursing Officers including Self Drawing and Disbursing Officers are hereby authorised to draw the Dearness Allowance at the revised rates from the date as shown below less the amount already drawn.

<u>Period</u>	<u>Revised rate of DA in %</u>	<u>Rate of increase in %</u>
1. From 1.7.2017	139% of Band Pay + Grade Pay +NPA	3%

Notes :-

1. The enhanced portion of Dearness Allowances is released to be paid in cash to all categories of employees under Government of Mizoram.
2. The arrear due to enhancement of Dearness Allowances by 3% from 136% to 139% w.e.f. 1.7.2017 shall be paid in cash to all categories of employees under Government of Mizoram.
3. The provisions contained in para 2, 3 & 4 of this department's O.M. of even No. dt. 26.7.2013 shall continue to be applicable while regulating Dearness Allowance under these orders.
